

1. GENERAL PROVISIONS

- 1.1. The Educational and Methodological Profile Committee (EMPC) is a permanent working professional body.
- 1.2. EMPC is organized for the purpose of ordering and systematizing educational and methodological, organizational and educational work and internship, improving the quality of the educational process of the departments of the I. K. Akhunbayev KSMA.
- 1.3. The EMPC is formed of:
- * Chairman: appointed by the order of the rector from among the professors, associate professors of specialized departments;
- * Secretary: elected from among the staff of the relevant departments;
- * Members of the profile committee:
- Faculty members from among the staff of the departments delegated to the EMPC according to the decisions of the department meetings;
- Representatives of professional associations, practical health care;
- Students:
- Parents.
- 1.4. The membership of the EMPC is approved at a meeting of the Main Educational and Methodological Committee (MEMC). (see Appendix 1. The organizational structure of the EMPC).
- 1.5. The EMPC is accountable to the Deputy Chairman of the MEMC and the Educational-Methodological Department (EMD).
- 1.6. The EMPC is guided in its activities by:
 - legislative acts of the Kyrgyz Republic;
 - regulatory documents of the Ministry of Health and Ministry of Education and Science of the Kyrgyz Republic;
 - internal regulatory documents.
- 1.7. The meetings of the UMGJ are held according to the approved plan and are

recorded. The protocol is signed by the chairman and the secretary, an

extract from the decision of the meeting of the UMPC is handed over to the secretary of the GUMC;

1.8. The Chairman of the EMPC annually reports on the work done at the meeting of the MEMC.

2. MAIN TASKS

The main tasks of the EMPC are:

2.1. Review and discussion of educational materials (methodological recommendations, textbooks, educational and methodological complexes of disciplines) on the basis of the department meeting decision;

- 2.2. Review and discussion of working programs in disciplines, modules, internship and elective courses;
- 2.3. Review and discussion of exam tickets, test tasks and situational tasks for the current exams;
- 2.4. Review and discussion of examination materials for the SAC;
- 2.5. Discussion of students' knowledge and their modernization control results (current, intermediate and final control, module-rating assessment of knowledge);
- 2.6. Providing recommendations on the organization of the educational process and teaching methods control.

3. INTERACTION

The EMPC, in accordance with the tasks assigned to it, interacts with:

4. RIGHTS

EMPC has the right to:

- 4.1. access to information methodological materials of departments;
- 4.2. check the educational and methodological documentation of the departments in agreement with the heads of departments;

5. RESPONSIBILITIES

EMPC is obliged to:

- 5.1. perform the assigned tasks in a timely and high-quality manner according to the approved plan;
- 5.2. conduct internal review of educational and methodological materials that are subject to subsequent review in the EPCO.
