REGULATIONS ON THE STUDENT COUNCIL

I. K. AKHUNBAEV KYRGYZ STATE MEDICAL ACADEMY

Preamble

We, the members of the Student Council of the I. K. Akhunbaev KSMA, united by the goal of creating the most favorable conditions for the progressive improvement of the intellectual and creative potential of the students of the I. K. Akhunbaev KSMA and achieving the comprehensive development of students by educating the qualities and skills of a highly qualified specialist in their field of activity, a true leader and patriot of their university and country, accept and undertake to comply with the regulations "on the Student Council" of the I. K. Akhunbaev KSMA

1. Basic regulations on the Student Council of the I. K. Akhunbaev KSMA:

1.1. The Student Council of the I. K. Akhunbaev KSMA is the main body of the student self-government of the I. K. Akhunbaev KSMA;

1.2. Full name in Russian: Student Council of the I. K. Akhunbaev Kyrgyz State Medical Academy;

1.3 Full name in Kyrgyz: I. K. Akhunbaev atyndagy Kyrgyz mamlekettik meditsinalyk akademiyasynyn studentik keneshi;

1.4. Full name in English: Students Council of Kyrgyz State medical academy named by I. K. Akhunbaev;

1.5. Location of the KSMA Student Council: Bishkek, 92 Akhunbaev str. (a), main building of the I. K. Akhunbaev KSMA;

1.6. The Student Council of the KSMA named after I. K. Akhunbaev (hereinafter referred to as the KSMA SC) is formed and carries out its direct activities in accordance with the Regulations on the KSMA SC, the KSMA Charter, the KSMA Code of Ethics, the Constitution of the Kyrgyz Republic and other normative legal acts of this university;

1.7. The competence of the student council of the KSMA extends to students of the I. K. Akhunbaev KSMA of all faculties and courses, to persons studying at the lyceum and medical school at the KSMA, as well as to such structural

organizations as: SPC, SSYSS, YFC, YDC, Enactus, Tutor Program, Mentoring Program "Unihood" and other creative and other organizations;

1.8. The Student Council of KSMA is the highest body of student self-government in I. K. Akhunbaev KSMA, and represents the interests of students of I. K. Akhunbaev KSMA at all levels of interaction;

1.9. The KSMA Student Council is established to protect the rights and represent the interests of students of the I. K. Akhunbaev KSMA at all levels of interaction, control over the performance of their duties, create the most favorable conditions and promote comprehensive development, progressive improvement of the intellectual and creative potential of students;

1.10. The Student Council of KSMA carries out its activities both directly on its own behalf and on behalf of the student community, through mutually beneficial assistance and cooperation with the administration, youth, trade union, human rights and scientific organizations, creative clubs and other associations of I. K. Akhunbaev KSMA and beyond;

1.11. The structure, activity plan, meeting schedule, current and annual report are approved by the Chairman of the Student Council of KSMA, in coordination with the university management.

2. The purpose and objectives of the Student Council of the I. K. Akhunbaev KSMA

2.1. The purpose of the KSMA Student Council:

2.1.1. Protection of the rights and representation of the interests of students of the I. K. Akhunbaev KSMA at all levels of interaction, control over the performance of their duties, creation of the most favorable conditions and promotion of comprehensive development, progressive improvement of the intellectual and creative potential of students.

2.2. Tasks of the KSMA Student Council:

2.2.1. Implementation of the Law of the Kyrgyz Republic "On the basics of State Youth Policy" and implementation of the State Strategy for Youth Policy, as well as creation of conditions for the implementation of National Target Programs (NTPs) for the development of youth of the Kyrgyz Republic within its competence within and outside the I. K. Akhunbaev KSMA;

2.2.2. Protection of the rights and representation of the interests of KSMA students at all levels of interaction (with the administration of KSMA and other universities

of the Kyrgyz Republic, with state management bodies, with law enforcement agencies, coordination and other state authorities, with public non-governmental commercial and non-commercial organizations, etc.), inside and outside KSMA, at the state and interstate levels;

2.2.3. Creating the most favorable conditions and promoting comprehensive development, progressive improvement of the intellectual and creative potential of KSMA students;

2.2.4 Educating students of the qualities and skills inherent in a highly qualified specialist in their field of activity, a true leader and patriot of the I. K. Akhunbaev KSMA and the Kyrgyz Republic;

2.2.5. Creation and implementation of conditions for providing leisure, professional self-training, independent development of intellectual and creative potential;

2.2.6. Increasing the level of employment of KSMA students with socially useful work;

2.2.7. Formation of guidelines for moral and spiritual values and high culture among KSMA students;

2.2.7. Support and promotion of talented and active youth;

2.2.8. Formation of an active civil position among KSMA students;

2.2.9. Organization and holding of public events (conferences, tournaments, competitions, symposiums, exhibitions, festivals, contests, forums, etc.), at the national and regional levels;

2.2.10. Promoting the spiritual and physical development of young people.

2.2.11. Integration of the youth of the I. K. Akhunbaev KSMA into the interuniversity, state and interstate space, by:

2.2.12. Creating conditions for mutually beneficial cooperation with representatives of youth governmental and non-governmental organizations in the territory of the Kyrgyz Republic and abroad;

2.2.13. Development of relations and relationships with organizations working with youth and implementing the state youth policy, national target programs of universities of the Kyrgyz Republic, CIS countries and abroad.

2.2.14. Organization and implementation of preventive measures aimed at fostering a legal culture, preventing the involvement of young people in criminal and other illegal activities, including extremism and religious fanaticism;

2.2.15. Creating and implementing conditions that ensure the continuity of theoretical knowledge and experience of outstanding figures of science, medicine, culture, art and sports, in order to preserve and increase the intellectual and creative potential of the university community and society as a whole;

2.2.16. Organization and participation in intellectual and sports tournaments, contests, competitions, subject and sports Olympiads;

3. Powers of the Student Council of the I. K. Akhunbaev KSMA

3.1. The Student Council of KSMA, in accordance with its purpose and relevant tasks, exercises the following powers:

3.1.1. Provides guidance, methodological support and coordination of the activities of organizations under the jurisdiction of the council (STC, SSYSS, YCP, YDC), Enactus, tutoring, mentoring and other creative and other organizations);

3.1.2. The KSMA Student Council protects the rights and represents the interests of students at all levels of interaction, exercises control over the performance of their duties, creates the most favorable conditions for obtaining higher medical and pharmacological education and promotes the comprehensive development, progressive improvement of the intellectual and creative potential of students of the I. K. Akhunbaev KSMA;

3.1.3. The Student Council of KSMA carries out its activities directly on its own behalf and on behalf of the students of I. K. Akhunbaev KSMA through mutually beneficial assistance and cooperation with the administration, youth, trade union, human rights and scientific organizations, creative clubs and other associations of KSMA and beyond;

3.1.4. The KSMA Student Council participates in the formation of the state youth policy, develops proposals on the main directions and priorities of the regional state youth policy and mechanisms for its implementation, on issues related to the interests of students of the I. K. Akhunbaev KSMA;

3.1.5. Participates in the implementation of measures to provide social, psychological, pedagogical, legal assistance and rehabilitation of young people, from among the students of KSMA and not only, who find themselves in a difficult

life situation, according to the list of difficult life situations according to the Law of the Kyrgyz Republic "On the basics of State Youth Policy»;

3.1.6. Participates in the organization and conduct and, directly, organizes on its own behalf cultural events, physical culture and health and preventive work with students, assists students in systematic attendance of academic classes, physical education and sports;

3.1.7. Attracts funds from organizations on a voluntary or contractual basis to carry out activities in the field of youth policy in the I. K. Akhunbaev KSMA and beyond;

3.1.8. Promotes the creation and functioning of educational and methodological centers, institutions of social services for young people, health-improving institutions (camps, centers, etc.), sports and recreation clubs, creative centers, as well as other organizations whose activities are aimed at solving the problems of young people;

3.1.9. Creates and carries out the activities of advisory councils on issues affecting the rights and interests of students, with the participation of representatives of youth organizations, the administration of KSMA and other interested parties for joint discussion and development of decisions of a recommendatory nature;

3.1.10. Participates in the formation and implementation of the state youth policy, through other forms not prohibited by the legislation of the Kyrgyz Republic.

4. The procedure for admission to and exclusion from the Student Council of the I. K. Akhunbaev KSMA

4.1. The composition of the KSMA Student Council is formed only from the number of students of the I. K. Akhunbaev KSMA 1-6 courses of study, who occupy leading positions in public affairs, without negative characteristics from the faculty and the KSMA student community.

4.2. The applicant for membership in the SC KSMA must show a positive side during the training, have personal or team achievements in terms of culture, spiritual sphere or creativity, have experience in participating and organizing social events, social and economic design, etc.

4.3. The members of the KSMA Student Council must share the goal set for the KSMA SC and their respective tasks, accept the Regulation "on the KSMA Student Council" as the fundamental document of the KSMA Student Council,

which they undertake to honor and observe as the basic law for the members of the KSMA SC.

4.4. For the members of the KSMA Student Council, in addition to the Regulations on the KSMA Student Council, it is mandatory:

4.4.1. To honor the Constitution of the Kyrgyz Republic

4.4.2. Compliance with the Law of the Kyrgyz Republic "On the basics of State Youth Policy»

4.4.3. Compliance with the Charter of the I. K. Akhunbaev KSMA;

4.4.4. Compliance with the Code of Ethics of the student of the I. K. Akhunbaev KSMA;

4.4.5. Adhere to the Development Strategy of the I. K. Akhunbaev KSMA in its activities.

4.5. The procedure for admission to the Student Council of KSMA:

4.5.1. Future applicants for membership in the SC of KSMA submit the following documents to the HR Department of the Student Council of KSMA:

4.5.2. A handwritten application addressed to the chairman of the Student Council of KSMA, in a special form;

4.5.3. A completed questionnaire (indicating data on previous work experience in public organizations, awards and merits, personal character, etc.);

4.5.4. A resume, indicating personal data, with a 3x4 photo;

4.5.5. Characteristics and letters of recommendation are welcome.

4.6. The HR department is obliged to accept the documents of the applicant for membership in the Student Council of KSMA, and provide him with the Charter of KSMA for preliminary acquaintance with the rules and regulations of the Student Council of KSMA;

4.7. The Student Council of KSMA decides whether to grant or reject the request to join the SC of KSMA.

4.8. Procedure for exclusion from the SC KSMA:

4.8.1. Compliance with the rules and norms of behavior for persons who are members of the Student Council of KSMA, prescribed in this document, is strict

and mandatory for all members of the Council, regardless of their position, length of service and experience in the Student Council, social and material-economic status, political, religious and other worldviews. Joining the Student Council of KSMA and agreeing to the content of the chapters of the Regulation "on the Student Council" imposes on the members of the Council norms of behavior, the violation of which entails such consequences as:

4.8.1.1. Oral warning of a member of the KSMA Student Council. An oral warning should be given in case of violations of the regulations "on the Student Council" of the KSMA on one point, or, if the task is not completed in a timely or accurate manner, without valid reasons, which may be-illness and departure for a long time, for a period of more than one calendar week.

4.8.1.2. A written warning about violations committed by a member of the KSMA Student Council. A written warning must be given in case of violation of the provision on three points, or in case of failure to complete the task, but the absence of a series

4.8.1.3. Removal from office - complete dismissal from office, with the removal from this person of all duties, and release from all tasks. It is necessary in case of violation of the provisions under three articles, or if the actions of a person do not comply with the goals and objectives of the KSMA Student Council, causing material damage and damage to the reputation of the KSMA Student Council.

4.8.1.4. Exclusion from the composition is the final measure of punishment, with removal from office in the Student Council of KSMA.

4.8.2. Exclusion from the Student Council of KSMA is carried out after a detailed analysis of the situation by the chairman of the Student Council of KSMA, or the deputy Chairman on behalf of the chairman, within 7 working days after receiving a complaint to the Student Council or committing illegal actions, at a meeting of the presidium of the Student Council of KSMA, as part of the chairman of the Student Council of KSMA, Deputy Chairman of the Student Council of KSMA.

5. Organization of the structure and order of interaction of the sectors of the Student Council of the I. K. Akhunbaev KSMA

5.1. Structure of the Student Council of KSMA: Chairman, Deputy Chairman, heads of sectors, secretary of the Council, student clubs, representatives of faculties (headmen of streams);

5.2. Chairman of the KSMA Student Council:

5.2.1. The activities of the SC KSMA are headed by the Chairman of the SC KSMA, who is appointed by secret or open voting between the current members of the SC KSMA, for a period of one academic year, approved by the order of the Rector of the KSMA. The students and the teaching staff of the KSMA are publicly notified about the past elections and its results, only after which the new chairman officially takes over the performance of his powers and duties assigned to him.

5.3. Candidates are selected according to the following criteria:

5.3.1. The candidate with the highest number of votes is elected;

5.3.2. The candidate must be a member of the SC and SPC for at least 3 (three) years;

5.3.3. The candidate for the Chair of the SC must have experience in the chairmanship of one of the sectors;

5.3.4. Active members of the SC and SPC have the right to vote;

5.4. Powers of the Chairman of the SC:

5.4.1. Directs the work of the SC, conducts meetings, coordinates the activities of the members of the SC to fulfill the tasks facing the Academy;

5.4.2. Organizes the work on the preparation and implementation of the work plan of the SC and the sectors;

5.4.3. Interacts with the Department of educational and mass organizational work, the SPC and the administration of the KSMA;

5.4.4. Raises the issue of encouraging students who have shown themselves in the academic and social life of the academy;

5.4.5. Raises the question of the exclusion from the SC of persons who do not properly exercise their powers;

5.5. The Chairman of the KSMA Student Council is fully responsible for the activities of the KSMA SC and coordinates the actions of the responsible persons, according to the above structure.

5.6. The Deputy Chairman of the Student Council of KSMA is elected by the chairman of the SC from among the members of the Council for a period of 1 year. The Deputy Chairman is responsible for carrying out the work during the absence of the chairman.

5.7. The secretary of the Student Council of KSMA is elected by the chairman of the SS from among the members of the Council for a period of 1 year.

5.8. Representatives of faculties:

5.8.1. Representatives of faculties (headmen of streams) represent and protect the rights and interests of students of their faculty.

5.9. Student clubs:

5.9.1. FRC-represents KSMA in various FRC games. They are the organizers of the interfacult games of FRC KSMA;

5.9.2. KSMA Debate Club:

5.9.2.1. Represent KSMA in the debate tournaments of Kyrgyzstan;

5.9.2.2. They are the organizers of debate tournaments within the walls of the KSMA;

5.9.2.3. Participation in various conferences.

5.10. Sports and recreation sector;

5.10.1. Participates in the organization and conduct of sports events held by the Department of Physical Education and the Faculty, in interuniversity sports Olympiads in various sports, as well as in its own sports events;

5.10.2. Annually participates in cultural and health-improving campaigns;

5.10.3. Organizes demonstration performances, demonstrating the results of active sports activities of the faculty;

5.10.4. Provides assistance in conducting inter-course and inter-faculty competitions in various sports.

5.11. The sector of cultural and mass work:

5.11.1. Participates in the organization of cultural and mass works at the faculty, the course;

5.11.2. Participates in the organization of meetings with outstanding doctors;

5.11.3. Organizes festivals, competitions and leisure activities for students;

5.11.4. Organizes visits to theaters, exhibitions, excursions, cinemas in order to improve the social culture of students.

5.12. Information Support sector:

5.12.1. The Information Support sector is designed to reflect the student life of the faculty and covers the activities of the SS KSMA in the social network.networks, information portals, and so on.

5.13. The information Support sector should maintain communication with the editorial offices of newspapers, magazines and other mass media, with the information services of the universities of the Republic.

5.14. Social Development Sector:

5.14.1. Organizes charitable events, both inside the university and outside the walls of KSMA;

5.14.2. Cooperates with the social sectors of other universities and with charitable organizations;

5.14.3. Is engaged in fundraising, for low-income families, and those in need of expensive medical procedures;

5.14.4. Create social projects, the purpose of which is improvement for students of KSMA.

5.15. Student Scientific Society Sector:

5.15.1. Participates in the organization and conduct of scientific student conferences, Olympiads and scientific circles;

5.15.2. Participates in the organization of competitions for the best student scientific work;

5.15.3. In every possible way promotes the development of research work and technical creativity of students, works to involve them in scientific student societies, scientific circles and other types of research work.

5.16. Fundraising sector:

5.16.1. Cooperates with Kyrgyz universities and NGOs;

5.16.2. Implements projects to improve student life and infrastructure of KSMA;

5.16.3. Engages in attracting sponsors to events organized by the SC;

6. Material and financial resources of the Student Council of the I. K. Akhunbaev KSMA sources of their formation

6.1. The I. K. Akhunbaev KSMA provides the KSMA SC with material property (premises for the structural divisions of the KSMA SC, necessary office furniture, office equipment, stationery, office supplies, etc.), provides communication facilities (Internet, work phone), which the KSMA SC uses for its needs, during the implementation of its activities on the rights of operational management. Also, the I. K. Akhunbaev KSMA allows the SC KSMA to use the services of the technical services of the KSMA (electrical repair service, plumbing, Internet, etc.).

6.2. The financing of the SC KSMA is carried out at the expense of:

6.2.1. Financial resources of the KSMA Foundation;

6.2.2. Membership fees of KSMA students to the Student Prof. Union Committee;

6.2.2. At the expense of voluntary membership fees of the SC KSMA;

6.2.3. External targeted investments;

6.2.4. Various grants from governmental and non-governmental organizations;

6.2.5. Sponsorship funds received from projects and programs for the implementation of student initiatives and other sources not prohibited by the legislation of the Kyrgyz Republic.

7. The procedure for the liquidation of the Student Council of the I. K. Akhunbaev KSMA.

7.1. The Student Council of KSMA can be liquidated only in case of failure to fulfill its tasks, arranged in accordance with the goal set for it;

7.2. The SC of the KSMA is liquidated by creating a commission for the liquidation of the SC of the KSMA, consisting of the rector of the I. K. Akhunbaev KSMA, the Vice-Rector for State Language and Educational Work of the KSMA, the deans of the faculties, the head of the Legal and Human Resources Department, the responsible heads of the faculties, the chairman of the SC of the KSMA, the deputy the chairman, heads of structures, only after a detailed analysis of the activities of the SC KSMA for the entire duration of its existence and if there are irrefutable arguments in favor of not fulfilling the SC KSMA's tasks;

7.3. The Commission for the liquidation of the SC KSMA must consider the issue of liquidating the SC KSMA within a period of not less than 1 calendar month, after which a corresponding decision is made. At each meeting of the commission for the liquidation of the SC KSMA, a protocol must be drawn up, with a list of council members and their signatures.

8. The procedure for making additions and amendments to the Regulations "On the Student Council" of the I. K. Akhunbaev KSMA

8.1. Amendments and additions to the Regulations "On the SC of the KSMA" are allowed only if the norms and rules prescribed in the Regulations "On the SC of the KSMA" contradict the Constitution of the Kyrgyz Republic, the current Law of the Kyrgyz Republic "On the Basics of State Youth Policy", the Charter of the I. K. Akhunbaev KSMA.
