About the organization of the educational process of the spring semester 2020 — 2021 of the academic year 2020 — 2021in the mixed learning format.

In order to ensure the quality of the educational process and safe learning conditions, taking into account the continuing unfavorable epidemiological situation at the republic, and in compliance with the order MOiN No. 19/1 of January 13, 2021 "On approval of the algorithm for organizing the educational process in the mixed learning format in the spring semester of the 2020-2021 academic year", call:

I. Educational and Methodical Department:

- 1. Organize the learning process in the spring semester of the 2020-21 academic year using a mixed learning format for students of the following courses and faculties, according to the schedule of the educational process *[Appendix /]* and schedule:
- 4-6 courses of the faculties "Medical science" and "Pediatrics»;
- 4-5 курсы faculty courses "Dentistry", "Medical and preventive business», "Higher nursing education", " Pharmacy»;
- 1-12 and 25-28 groups of the 1st year and 6th year of the Faculty " Medical business with English language of instruction»

c using the following algorithm:

- practical classes in all disciplines, including courses *of* students ' choice (elective courses), and such methods of practical training should be conducted in the traditional format, while the duration of classes should be reduced to 60 minutes (2-hour lesson).) and 90 minutes (3-hour class); in this connection, the beginning of 3-hour classes scheduled for the first time in pairs will be postponed to 7h30min.;
- lecture classes in disciplines of all cycles of the curriculum should be conducted remotely using distance learning technologies ;
- clinical departments located on the territory of medical institutions that are included in the" red zone " should allocate classrooms in free academic buildings for temporary use .
- 2. For students of other courses and faculties, namely :
- 1-3 year students of the faculties of "General medicine", "Pediatrics", Stomatology»,

"Medical and preventive business", "Higher nursing education», "Pharmacy»;

• 13-24 groups of the 1st year and 2-5 courses of the faculty "Medical business with Englishlanguage of instruction»

save training in remote mode using remote educational technologies.

3. State certification of graduates of the Faculty of Pharmacy on the basis of higher medical education should be carried out remotely using dietary and educational technologies.

4. Comprehensive State exam "Stories of Kyrgyzstan»,

"Kyrgyz language and Literature" and " Geography Knrgyzstan" for 2nd -year students to conduct in remote mode, taking into account the "Recommendations for conducting the final state certification of graduates of higher and secondary vocational education institutions 2020 mda in online mode" using distance educational technologies.

5. Conduct regular monitoring and control of the educational process.

- II. Head of the System and Software Department (Zhenishbek kypy M.): ensure timely recording of audio lectures in all disciplines,
- III. Dean of faculties:
 - 1. To inform students about the resumption of training in the traditional format, the algorithm of training and the requirements of the anti-epidemic regime;
 - 2. make lists of students from near and far abroad who are studying in the 4th year of the faculties of "Medical science", "Medical and preventive care" and "Dentistry " students who will be allowed to start classes from 21.01.2021 г. without completing practical classes;
 - 3. bring this information to the attention of the relevant departments.

IV. To the Safety Engineer (To Z. T. Ismailov.):

To prepare and post on site KSMA, information materials on the prevention of the spread of COVID-19 on the caitte website of the KSMA, as well as in other accessible places.

- V. Head of Departments:
 - 1. ensure compliance with the sanitary and epidemiological regime in the departments;
 - 2. provide support for financially responsible senior laboratory assistants in the following areas: ordering supplies for COVID-19 prevention from the KSMA warehouse,
- V. Head of the General Department(Petrumevskaya T. N.): ensure that the order is distributed to all structural divisions.
- VI. Control over the execution of the order should be entrusted to the Vice-rector for Academic Affairs Alymbaeva E.Sh
